Domestic violence can be physical violence, emotional abuse, financial deprivation, or sexual violence. Domestic violence is any behavior in which the purpose is to gain power and control over a spouse, partner, girlfriend/boyfriend or family member.



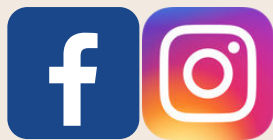
What does domestic violence look like?

- Telling you that you never do anything right.
- Showing extreme jealousy
- Preventing or discouraging you from spending time with friends, family members, or peers.
- Insulting, demeaning, or shaming you.
- Preventing you from making your own decisions,
- Controlling finances in the household.
- Pressuring you to have sex or perform sexual acts you're not comfortable with..
- Intimidating you through threatening looks or actions.
- Insulting your parenting or threatening to harm or take away your children or pets.
- Intimidating you with weapons
- Destroying your belongings or your home.

Emergency Shelter

What to Expect

A brief telephone interview is conducted to determine the needs of the individual and if our services are appropriate.

Upon intake, you will be greeted by a caring staff who will assess your needs and provide you with food, clothing and a clean, safe place to stay. The length of stay at Haven House varies up to 90 days and depends on each individual's situation.

As you begin the healing process, Haven House can provide support from caring staff by offering education about domestic violence, counseling, advocacy and referrals to other agencies which can provide additional support to you and your children.

Haven House also supports individuals outside of shelter with referrals and support groups to provide life long tools to maintain a life free of violence.
